DELIBERAÇÃO: Após exame e discussão da matéria constante da Ordem do Dia, foi aprovada, pela unanimidade de votos dos acionistas presentes, tendo sido computados 100% de votos dos presentes a favor, representados por 416.517.663 ações, conforme orientações de voto recebidas pela Companhia e arquivadas na sede social, a aquisição, pela Companhia, da totalidade das quotas de emissão da Odonto System, nos termos do artigo 256, inciso I, da Lei das S.A., conforme operação

divulgada no Fato Relevante da Companhia de 14 de novembro de 2017 e no Comunicado ao Mercado de 20 de julho de 2018.

Fica ora consignado que, nos termos descritos na Proposta da Administração, o disposto no inciso II do artigo 256 da Lei das S.A. não se aplica à matéria ora aprovada pelos acionistas e, portanto, a presente aprovação não implica em direito de recesso aos acionistas da Companhia, conforme previsto no §2º do artigo 256 da Lei das S.A.
